All contracts for the 2018 have been signed and returned with deposits with the exception of Pocono which happens later in the year.

The van is in storage and will be serviced and detailed shortly to get ready for the season.

Overall, January was a slow month with most of the activity coming from DE and P4US.

It is worth noting, the cash balances in the two operating accounts was up from January 2017 to January 2018. Much of this was due to the decrease in the deposit for Watkins Glen that was paid in January. Because the Glen DE event this year is 2 days vs. 3 days & it is mid-week as opposed the weekend. This gave the Club a significant savings. The remaining surplus is due to an unexpected surplus from VIR and a check for our portion of the Mt. Tremblant revenue that came late in the year.

Steve Cordemus has been busy collecting ad revenue for P4US. Thanks Steve! However, some of the money collected in January will go towards closing out 2017 advertiser's balances. We incurred the usual monthly expenses to produce P4US.

For January 2018, DE had 2 outgoing expenses for the April Lime Rock DE and a Watkins Glen DE deposit.

The charity reimbursement was received from PCA National.

Vehicle/Trailer cost of \$884.80 was for 4 months of storage at Power Portal.


NNJR ended the month of January with 2271 Primary Members (+13 from December) and 1508 Family/Affiliate Members for a total of 3780. Expired Membership Survey:

198 former members whose memberships expired between January and September 2017 received an invitation to complete a quick five-question survey via surveymonkey.com. While the survey response rate was too low to date to gain statistically relevant insights, it's worth noting that one-fifth of the non-renewals were only in the club for one year while nearly half (49%) were members for five years or less. This data proves we need to make a concentrated effort during a new member's first year to make them feel welcome as well as getting them engaged in an activity that will keep them coming back.



New Member Gathering Saturday, February 10th 9:30-11:30 am at Paul Miller Porsche: Personalized invitations went out to all new members dating back to June. Based on the insight above we will expand the invites to all 2016 and 2017 new members as a way to improve new member engagement before 2018 club activities start to ramp up.
