- 1. I have given the NJ Police Report form, filled in to our Secretary (Cindy).

- 3. We will run those events with, at minimum, RTR and Central PA PCA, possibly at least one with SCCA
- 4. We have verbal confirmation of Flemington's sponsorship, but i have not heard from their marketing professional and have not seen a contract. I will follow up when i return. If Bill or Ken happen to be there, please feel free to check on those items.
- 5. The CCC registration is now open on Motorsportreg.com. We have 21 signed up already.
- 6. Toward the end of the month Justin and I, at minimum, will get together to dry run the new AX equipment.
- 7. I do need volunteers to help tend to the equipment, set up equipment (onsite), learn Axware and run Axware (do the timing job at events)

Attached please find the collection report as of today. First quarter invoice payments were due February 28th. Late payment in the first quarter is typical because it is the slowest business season for many of our advertisers. Second quarter invoices will go out the first week of April.

I promoted annual contract payments in the invoice. We have one additional annual advertiser - Ray Catena.

I will work with Ellen and Kevin to identify advertisers in good standing to host concours events as per our policy. James Coleman of the Tech Committee is checking with me regarding hosting events at advertisers in good standing place of business.

### **Charity:** [Hubert King]

After a lengthy process, starting in the fall of 2019 when The Charity Committee solicited nominations from all club members, the committee has reached a unanimous decision for Cheshire Home. We are bringing that suggestion before the Board of Governors for their approval.

The process of evaluation started when our President selected a sub-committee from the Board of Governors to evaluate the nominated charities. After consideration of all nominations, the Nominating Committee narrowed the choice to four possibilities.

In each case, we believed that our members would strongly support their mission. To better understand the organizations and see first hand their work, our Committee arranged on-site visits. Typically we spent several hours getting to know the staff and, when possible, the individuals receiving benefits. We knew from our experience at Employment Horizons that impacting individuals' lives was an important element in selecting a charity that members could get behind.

The Nominating Committee met before the NNJR Monthly Meeting on February 18 with our list of pros and cons for each organization and reached a unanimous vote for Cheshire Home.

The mission of Cheshire Home is to help young-adults with spinal cord injuries or neurological impairments to recover their lives. What sets Cheshire Home apart from traditional nursing facilities is the young adult population and the focus on each resident's ability to transition to independence. It provides medical care for those severely affected along with physical and occupation training. It is the only stand-alone facility of it's kind in NJ and is unique even in the US with only Shepard House in Atlanta offering similar care. It is a compact, focused facility that houses 35 critical-care live-in patients, with an additional 14 less-critical care clients housed in two community-based homes located in surrounding community. The goal is for

clients is to attain life skills that allow them, as much as possible, to live independently. An average stay is two and one-half years.

They meet all of our Guidelines for NNJR Charity Sponsorship. It is a local organization; the facility is located at 9 Ridgedale Avenue, Florham Park, NJ 07932. Appealing is their moderate size, we can have a real impact on their annual \$300,000 fundraising, which will place us in the top 5 Tier of supporters. Their operating budget however is much larger, ~\$13 million, supported by grants, Medicaid, and private insurance. They fulfill all of the non-profit tax criteria and are quite familiar with running charity events and the licensing requirements. They hold an annual "Casino Night". Their staff members would be happy to work with us on our own event.


**February 29th New Member Gathering Post-Mortem:** While Saturday's New Member Gathering was our best attended to date and feedback from new members thus far has been good, in the spirit of "there's always room for improvement", we've captured our thoughts here for how we will improve moving forward:

- Event Timing holding an event at PMP on the last day of a sales month clearly is too hectic. Between the lack of parking and insufficient folding tables for gathering at the opposite end of the showroom, its clear we're better off scheduling on the first Saturday of a month where we can use the *Porsche Exclusive Manufaktur* alcove for registration and serving breakfast.
- Amplification Soft voices, ceramic floors, a high ceiling, and side conversations conspire to make it difficult for new members to hear most presenters. We have a guitar amp and a microphone that works well (proven during Karaoke parties at our home, but that's a story for another time), so we've added that to our set up equipment list moving forward.
- New Member Gathering Goal when Marlys handed over membership duties, she made it abundantly clear to us, and we quote: "Just remember: membership growth and retention drives the club, not any single program. Don't let anyone try to tell you differently." We

need to continue to keep this goal in mind in structuring our events. The goal of our New Member Gatherings is simple: give new members a great first impression, make them feel welcome, give them an overview of all of the programs available by members of the BOG, and when they ask about a program, get them in touch with the appropriate person.








Overall Membership: Primary memberships as of March 1st continues to hold steady at 2,311. Combine that with 1,452 Family and one life member and NNJR's total membership currently stands at 3,764.

**Transfers:** the lone transfer in and two transfers out all appear to be move-related.

**Non-Renewals**: Non-renewals for February totaled 33, so our e-mail-only efforts after one year to contact people to renew continue to work effectively.

Non-renewals among NNJR members with less than five years tenure ended at 38.8% for 2020 versus our 2017 benchmark of 49.0%.
