**CALL TO ORDER:** The meeting was called to order by President, Ron Miguel, at 7:29pm.

**APPROVAL of MINUTES:** Knute Hancock moved to accept the previously distributed draft minutes from the February 2024 meeting as final. Motion was seconded by Doug Holcomb and carried by majority vote.

## **III. New Business:**

- A. **2024 Budget** Steve Eisenberg thanked the BOG for their assistance in following up on the remaining issues, and reviewed the changes made since last month. Discussions during the meeting led to few additional tweaks being made. Steve will circulate a final copy to the BOG. See Motions Passed During Meeting below.
- B. **P4US:** New Directions Ted DuPont shared the plans for the next print version of the magazine; it will essentially be a duplicate of March's digital issue. Once final approval is received to begin printing, it should take approximately 15 business days to print which should result in mailing by March 28<sup>th</sup>. We anticipate printing 3000 copies.

The BOG is reminded that the deadline for content submission for the April magazine is March 16<sup>th</sup>. Ted will oversee production of the April and May magazines, then step down from the position of Editor.

- C. **Four-Door Event Update** Steve Eisenberg, Rudy Samsel, and Peter Schneider have been collaborating on creating brief, low-commitment, family friendly events to attract new segments of the membership. The first such event "Pizza and Porsches" is scheduled for March 30<sup>th</sup> at Kichley's Pizza restaurant in Ramsey, NJ. The event will be advertised in P4US, eblasts, website and across our social media platforms. Future events are planned for June 1<sup>st</sup> and August 4<sup>th</sup>. Details to follow.
- D. **ID Badge Proposal** Steve Eisenberg described a successful ID badge program used by his former region. Our existing badges are dated and have not been ordered for event chairs for several years. The proposal contemplates producing the initial batch of badges for the BOG, and to expand from there. We'd need to determine how best to roll out availability to the membership. Steve will continue to refine the proposal and present a plan and associated costs to the BOG.
- E. **Advertising Sub-Committee** To help streamline our current processes and help create a uniform advertising strategy, an Advertising Sub-Committee comprised of Ron Miguel, Dyke Hensen, Nicole Callen, Anthony Wartel, and Rich Barry will be formed effective immediately.

## New Membership Enrollments

There's no sugarcoating it: new membership enrollments slowed in 2023 and continued that trend for the first two months of 2024:

- Only nine enrollments for February 2024 tie the previous low set in 2019. Combine that with only 15 newbies in January (the lowest level since 2016)
- The slowdown in sports car sales (the primary driver of our club enrollments) appears to be a driver. Here is the breakdown of the Porsches owned by the 24 new members enrolled so far this year:

• Without a commitment by the local dealers to actively promote the club to four-door buyers, this trend will continue until consumer sentiment with the economy improves.



Status report: March print issue

- Standard Group received final approval today: they are moving ahead with the printing process. Estimated time frame:
  - o March 28: Issues mailed (15 working days)
  - o Week of April 1: NJ members receive issue in mail (out-of-state will be longer)
- Total of 3,000 issues will be printed (last year: 2,950 printed)
  - o 2,400 issues will be mailed to members (2364 active members)
    - I'll work with Rudy to provide mailing list in format required.

- o 600 extra for club leadership / reserve
- Action Item for decision:
  - o Last year: 20 members had shipments of 20 books each, with one shipment of 150 to Rich Barry (total 550).
    - Should we keep that allocation? Who were the 20 members--or were they shipments to advertisers? How many issues should be shipped to Ron?

We are currently reviewing contract for the Holiday Party, scheduled for Friday, December 6th at The Highlawn.




The social media properties showed a growth in members, followers and engagement.

## Facebook


- Membership on the private Facebook group grew from 988 to 994.
