The 2025 DE season has been set. I've been working with Mid-Ohio, NY Metro, Potomac, and Allegheny PCA regions. This will be our second year splitting the financials with MOR at Mid-Ohio Sports Car Club. NY Metro has agreed to advertise our Mid-Ohio and VIR events to their members. They have not booked their Summit Point DE for 2025, normally the week following VIR. We've have reciprocated by agreeing to advertise their Palmer and Lime Rock events. While we have worked well with the other two clubs in the past, I don't yet have them agreeing to support any of our events, even though we have theirs on our calendar. Disappointing.

Most of the contracts have been signed, and deposits sent. We again have Mother's Day weekend at Mid-Ohio in 2025. The track rate has been increased by almost 24%. I'm still awaiting an answer from them to reduce our track fee due to the holiday weekend. VIR has yet to send their contract.

Below is our January 2025 monthly update on Membership, New Member Trends, and specific related activities through January 1, 2025.

It's with a heavy heart that we announce this will be our last report, but we are confident that Anthony Margaritondo will be in great hands with these duties.

### New Membership Enrollments

- For 2024, NNJR signed up 217 new members, exceeding our plan of 200 by nearly nine (8.5%) percent.
- While we exceeded our conservative plan, New member enrollments for 2024 declined (-5.2%) from 2023.



## **Overall Membership**

Year-over-year, NNJR member enrollments declined slightly:

- Primary memberships, as of January 1, 2025, stand at 2,356. This represents a decline of (-1.2%) year-over-year.
- Family memberships, as of January 1, 2025, stand at 1,290. This represents a decline of (-3.2%) year-over-year.
- NNJR's total membership remains steady at 3,646, a decline of (-1.9%) compared to the prior year.

PLEASE NOTE: the graph below features a revised Y-Axis numbered from a minimum of 2,000 to a maximum of 4,000. We implemented this change better to illustrate the trend lines between primary and associate members
